

Now That's Perfect Video Contest Terms and Conditions

- 1. Eligibility: This Contest is open only to those who sign up at http://go.mohawkflooring.com/now-thats-perfect and who are 18 as of the date of entry. The Contest is only open to legal residents of the U.S. and is void where prohibited by law. Employees of Mohawk Carpet Distribution, Inc. ("Mohawk"), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations.
- 2. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Mohawk.
